

# MINUTES OF THE MEETING OF THE CABINET TUESDAY 10 MARCH 2015

### 37. **Declarations of Interest**

There were none declared.

### 38. Minutes

The minutes of the meeting held on Tuesday 10 February 2015 were approved as a correct record and signed by the Chairman.

### 39. Public Open Space Areas in Gamston

Members noted that this item had been withdrawn before the meeting.

### 40. Off Street Car Parking Bingham and Radcliffe on Trent

Councillor Cottee presented the report of the Executive Manager – Finance and Commercial in respect of potential amendments to parking arrangements for the off-street parking bays in Bingham Market Place and car parks in Radcliffe on Trent. If any changes were agreed then the Council's Off Street Parking Places Order 2009 would need to be amended. Any changes to the Order would be delegated to the Cabinet Portfolio Holder - Communities and Leisure in consultation with the Executive Manager - Finance and Commercial

He stated that parking surveys had recently been carried out in both areas and it was proposed that a formal consultation exercise should be carried out. This exercise would last for six weeks and would include writing to parish and town councils, local business and advertising the proposed changes in order to seek people's views.

In supporting the recommendation Councillor Clarke stated that this approach reflected the local communities' comments.

# **RESOLVED** that

- a) The Council undertakes a consultation exercise on the following potential amendments to the Parking Places Order:
  - To introduce, excluding Sundays and Market Days, a two hour time limit to off street parking within Bingham Market Place.
  - To allow, on Market Days, public off street parking in Bingham Market Place from 16:00 onwards.
  - To restrict public parking in the Health Centre Car Park, Radcliffe on Trent to a maximum of three hours.
  - To introduce a drop-off zone within the Health Centre Car Park, Radcliffe on Trent with a maximum waiting time of 15 minutes.
  - To restrict public parking in the Walkers Yard Car Park, Radcliffe on Trent to a maximum of three hours.
- b) That decisions on amendments to the Parking Places Order resulting from this exercise be delegated to the Portfolio Holder Communities and Leisure in consultation with the Executive Manager Finance and Commercial.

The meeting closed at 7.05 pm.
