### 20. Review of the South Nottinghamshire Community Safety Partnership

Superintendent Anderson and Ms Jackson gave a presentation on the Partnership. Members were informed that the Partnership had undergone some changes and was now providing sustainability and was effective. The Group was told that the merger of the three partnerships of Broxtowe, Gedling and Rushcliffe in 2008 was recognised nationally as a positive step. The Partnership was now coterminous with the Police division and could share resources and expertise over the three boroughs.

Members were informed of the crime statistics for both South Nottinghamshire and Rushcliffe for April to December 2010, with comparable data from 2009. In South Nottinghamshire the overall crime figures had been reduced by 14.2% (approximately 2,000 incidents) and in Rushcliffe this equated to 10.3% (approximately 400). In both cases serious crime statistics had reduced, however anti-social behaviour had increased, although this could be due to increased awareness and better reporting. The Group was informed that of the three boroughs Rushcliffe had the lowest crime figures. Superintendent Anderson explained that the performance figures for 2010/11 for the Police had been amended three times and although it was recognised that the final targets were ambitious and that some of the targets might not be met during the year performance had increased in the last three months and the targets would be reached during the early months of 2011/12.

Whilst explaining the priorities and achievements for 2010/11 Superintendent Anderson emphasised the work carried out by the Partnership and he highlighted the Integrated Offender Management project which took an holistic approach to preventing people re-offending, this included help with employment, drugs and family issues. He stated that 70% of those people involved in the project were successful. Superintendent Anderson felt that without the hard work and dedication of the Community Safety Officers the Partnership would not be able to achieve such successes or be effective.

In comparison to other areas in Nottinghamshire it was noted that the Trent Bridge ward was ranked third and Cotgrave 14<sup>th</sup>. He explained that the Trent Bridge ward had a thriving night time economy and was also in close proximity to Nottingham City and an area based initiative had taken place. Cotgrave had been targeted to reduce anti-social behaviour and each incidence had been given a crime number.

As part of the Partnership's approach for 2011/12 Superintendent Anderson gave a brief outline of the new Police arrangements and how the Nottinghamshire force was to be split into a City and a County Division, that some services such as helicopters and horses would be shared with other forces, however front line delivery would be protected. He stated that the Partnership would be concentrating on a geographical focus rather than a thematic approach, and would be targeting specific problems within the community. It was felt that this would be more effective.

Superintendent Anderson also stated that the shared services in West Bridgford between the Council and the Police was a brilliant initiative and would provide residents with a one stop shop approach.

Members congratulated Superintendent Anderson on his presentation and the positive implications. It was felt that the Police were improving even though they would not quite meet their aspirational targets.

Following a question Members were informed that Operation Cypher targeted known offenders coming into the area and relating their details to any crimes occurring, this had led to police officers being stationed on the bridges over the Trent but the information gathered needed to be considered to ascertain if it was sustainable.

In relation to the night time economy many incidents could be linked to alcohol and Superintendent Anderson stated that as all local licensees were, through the Partnership, working to reduce crime this could lead to more incidents being reported without an increase in crimes.

It was felt that Members could assist the Partnership by communicating to people how, although they might feel that the Police were not visible, resources were to be targeted into areas of need. Some Members felt that the way the statistics were displayed could be seen as misleading as some of the larger villages were collated together whereas others were split. Ms Jackson explained that the data was shown by ward area and was expressed as crimes per 1,000 people.

Following a discussion Superintendent Anderson stated that the Partnership worked with young people on initiatives however he felt that more work was required with young children as the problems did not start at secondary school. He was also concerned that with budget cuts there would not be sufficient money to target diversionary tactics.

Councillor Fearon, as Chairman of the Strategic Board, stated that the Partnership worked together to achieve the targets, that the Partnership needed to reprioritise its spending due to the threats surrounding its budget, that work needed to be focussed on the very young and that as a Council Members needed to support the initiatives.

The Chairman concluded that the South Nottinghamshire Community Safety Partnership was highly regarded and used as an example nationally. He stated that Rushcliffe was the third best place to live in the country if crime was not included and it was hoped that this could be improved with the continuing success of the Partnership.

The Chairman thanked Superintendent Anderson and Ms Jackson for attending the meeting and answering Members' questions.

It was AGREED that the improvements in performance made by the South Nottinghamshire Community Safety Partnership over the past year in reductions in household burglaries and vehicle crime be acknowledged.

### 21. Update on the Partnership with Nottinghamshire County Cricket Club

Nottinghamshire County Cricket Club, as part of the loan agreement in 2008, agreed to provide a community benefits package until 2023, these ranged from road shows, helping local groups and charities, cricket coaching for schools and club development. Ms Francis had also secured funding from the Home Office until 2012 to provide Positive Futures, a social inclusion project in Cotgrave.

Ms Francis gave a presentation to the Group updating Members on the work carried out during the year. She highlighted work undertaken to:

- support clubs, including the 34 club mark accredited clubs in the Borough, especially Plumtree Cricket Club who would, in 2011/12, also become a disability hub club
- fulfil the national Chance to Shine campaign, working with six schools in the Borough to provide coaching and links to clubs
- general encouragement by making children match day mascots, making donations of tickets and bats to help raise money for community groups, schools and charities

- coaching for primary schools and after school clubs, 13 primary school teachers were trained and classes were invited to the Trent Bridge classroom for sport and lessons
- ensure that young people were included in the Academy and Emerging Players programmes
- there was a focus on women and girls' cricket

Members were also informed that two volunteer co-ordinators had been appointed and that twenty junior sports leaders had been trained as England Cricket Board Young Officials. Ms Francis also explained that these young people had been part of the npower Urban Cricket World Record Attempt 2010, which had included teams 80 teams, or 2010 children, playing cricket at the same time. There had been ten teams from Rushcliffe, including three winning teams. The event raised over £4,500 for local charities and every child involved received an urban cricket bag. Other achievements in 2010 for Nottinghamshire County Cricket Club included receiving national awards for the 'best community programme' and 'best website'.

Ms Francis outlined the progress made on the Positive Futures project over the last year. The project consisted of various sports and arts activities. She explained that the jewellery making activity had evolved into a social enterprise organisation. Key achievements for the year included improved behaviour in school, with two young people being prevented from exclusion and one young person gaining a GCSE qualification a year early; girls only provision; dance group established; involvement of all major partners in the locality; huge reduction in anti-social behaviour and a successful Community Pride Project.

Finally Ms Francis outlined the priorities for the forthcoming year, which included work in the wider community, further opportunities for young people between the ages of 16 and 19 and expanding the apprenticeship scheme.

Following a question regarding costs the Deputy Chief Executive (CB) explained that the loan had helped the Ground achieve international and Twenty20 status. When the loan had been arranged the agreement was that the Council would receive 4% interest, which at the time had been subsidised, however in the current climate this was exceeding other interest rates. Members noted that the interest received from this loan was not ringfenced. Also at present the Council's only input was staff time into the partnership.

Some Members were concerned about the rise in crime in the Ruddington area and asked if there was a gap in sports provision in that area. Ms Francis explained that the Positive Future's project was tied into a geographical area and could not be transferred and that there were opportunities for young people to be involved in the holiday programmes at Trent Bridge. Councillor Vennett-Smith explained that Ruddington had two cricket teams that were growing.

The Group felt that the community benefits were excellent and the work the Club was undertaking was very positive. Their only concern was that the accredited clubs were growing stronger whereas other clubs could struggle. Ms Francis explained that schemes were now being introduced to help emerging clubs as well as accredited clubs, which were helped through funding from the English Cricket Board. Also in 2011/12 on of the targets for Nottinghamshire was to increase support for adult participation, including the 'last man standing' and 'return to cricket' programmes. Another initiative to help clubs was the 'adopt a wicket' campaign.

The Deputy Chief Executive (CB) drew Members attention to the funding that the Nottinghamshire County Cricket Club had successfully obtained and when these would potentially end. He also stated that there would be a review of the benefits package in December 2012 and that it might be appropriate for the Council to reconsider this issue then.

It was AGREED that the Partnership Delivery Group expressed their pleasure on the delivery of the programme of community benefits over the last year and expressed the wish that officers work with Nottinghamshire County Cricket Club to ensure that this level of benefits continues past 2012.

### 22. Work Programme

The Group considered their work programme.

Councillor Lawrence explained that a review of the list of partners had been included in the meeting for June 2011 for the benefit of new members.

Councillor Jones stated that the Fire and Rescue Service were in consultation regarding restructuring and asked that consideration should be given to include this in the work programme.

Partnership Delivery Group AGREED the proposed work programme for 2010/11.

The meeting closed at 9.30 pm.

# **REPORT OF THE HEAD OF COMMUNITY SHAPING**

### Summary

- 1. In 2009 a follow up review into the Rushcliffe Community Partnership was undertaken as part of a Peer Challenge. Their report contained recommendations which were incorporated into an action plan to cover the Management Board, the Executive, the Theme Partnerships, wider Community Engagement, and Support Arrangements which were approved by the Local Strategic Partnership Board. Work began in August 2009 to implement the action plan, including ensuring that the priorities of the Sustainable Community Strategy were delivered by the themed groups.
- 2. The Head of Community Shaping will give a presentation outlining the progress of the six themed action plans including highlights and exceptions. The six themes within the Rushcliffe Sustainable Community Strategy are Building Stronger Communities, Business, Children and Young People, Community Safety, Environment and Health. The presentation will include a report on the Local Area Agreement funding of £349,000 received by the partnership and an update on the allocation of this funding and projects underway and completed. Information will be provided to Members on the current position of Local Strategic Partnerships across the County and the impact of Nottinghamshire County Council's decision to withdraw support for the Rushcliffe Community Partnership. The presentation will also update members on the Action Plan for the Local Strategic Partnership for the next 12 months.

### Recommendation

It is RECOMMENDED that Members consider the presentation and endorse the work of the Rushcliffe Sustainable Community Strategy Action Plans.

# What we do

The main role for Rushcliffe's four scrutiny groups is to:

- Develop a programme of scrutiny focusing on priority outcomes for the community
- Ensure that this work helps the Council to implement its plans and policies effectively.
- Challenge and question existing policies and the way services are delivered and recommend any improvements to Cabinet and Council.
- Ensure that scrutiny helps the Council to improve, implement best practice and provide excellent value for money.

The Partnership Delivery Scrutiny Group's specific role is to:

- Make sure existing partnerships are effective and grow and develop
- Help ensure partnership working is considered the norm to ensure benefits such as synergy, better use of assets and resources, better value for money, remove duplication etc
- Forge public sector partnerships to deliver community benefits
- Develop an approach to future partnership working with both the public and private sector

# Our work this year

The main thrust of the work continued to be monitoring services, helping develop policy and consultation prior to Cabinet.

During the year the Group considered many services and issues, particularly:

- Effectiveness of designated public places orders in Rushcliffe
- Domestic violence support work
- The wide range of partnerships
- Working with Sure Start
- Annual review of the Rushcliffe Sustainable Community Strategy
- Annual review of partnership with Spirita
- Annual review of leisure centre contract with Parkwood Leisure
- Annual review of First Lets and future options
- Update on the partnership with Nottinghamshire County Cricket Club

### Designated public places orders

In June 2010, the Group discussed the use and implementation of the designated public places orders in Cotgrave, West Bridgford and Radcliffe on Trent. These orders represent one way the Council and the Police work together to curb anti-social

behaviour and underage drinking. The Group concluded that the orders had led to a general decrease in crime, had proved popular with residents and are an effective multi-agency approach. Combined with other initiatives such as Positive Futures in Cotgrave to engage young people likely to be on the verge of a life of crime, partners felt these orders were having a positive impact on keeping Rushcliffe as the safest place in Nottinghamshire. West Bridgford differs from Cotgrave in that it has a vibrant night-time economy which brings the risk of a different sort of anti-social behaviour, for example, street drinking and drug use. However, partners are working with bars and City colleagues and the Trent Bridge Week of Action in December 2010 allowed for a more targeted approach to continue.

### **Domestic violence support**

The Scrutiny Group was updated in June about the excellent work carried out by the Council's domestic violence coordinator and partners, plus the comprehensive support mechanisms in place which are highly appreciated by clients. The Group learnt about work in schools to increase 'respect' and reduce bullying and sexual abuse, as well as about the Freedom Programme, the Sanctuary scheme and time-specific campaigns such as those run around Christmas. Some future plans were explained, namely to expand rural access points, hold another community theatre event and to have thought provoking street theatre at the youth event Bridgfest. The Group was made aware that Cotgrave had a high level of reporting of incidents due to a focus of services located there eg Sure Start and Trent Bridge had a high level of repeat incidents, perhaps due to the lively night-time economy.

### Partnerships

The group discussed an up to date list of Council partnerships - ie who the Council worked with, on what projects and the costs involved. In summary, the Scrutiny Group concluded that there were a wide range of partnerships in operation which would need close scrutiny given the current uncertain economic position.

### Working with Sure Start

The Group found out more about the Council's involvement with Sure Start which is run by Nottinghamshire County Council and aims to provide early support for parents and carers to ensure children are safe, well looked after, eat properly, develop and achieve their potential at school. The service helps to reduce teenage pregnancies, reduce childhood obesity, help children in workless houses, helps eliminate deprivation and the success is very much dependent on a multi-agency approach. The Group was told that the future of the service was unclear in difficult economic times. Sure Start had been helped by the work of the Council's housing options team, as well as specific help from the domestic violence coordinator. The Group endorsed the work being undertaken by the Borough Council in relation to Sure Start.

### Annual review of partnership with Spirita



Every year the Group reviews partnership arrangements with Spirita to ensure the relationship remains productive and that residents are getting good value for money. The Group learnt that since 2003, 250 affordable homes had been built in the Borough and this far exceeded the target of 150. This level of achievement was particularly praiseworthy in a subdued house-building market. Members learnt that Spirita was on target to ensure all its homes were of a 'decent' standard by the end of 2010.

At the previous annual review the Group was concerned that the responsive repair service was not meeting tenant's expectations. However, one year on this problem had been addressed as evidenced by a significant fall in complaints and by working with another repairs contractor. Spirita also addressed other areas of previous concern, reporting that estate inspections were now regular and well publicised with residents becoming involved. The number of voids was now improving with a new incentive to encourage tenants to leave properties in a good state of repair by offering a financial incentive. Spirita updated the group on sheltered homes, highlighting people's changing tastes and expectations about retirement living, pointing out that some stock was now over 30 years old and not suitable for elderly people. However, this Notts-wide issue was being addressed by a new group led by the Council's strategic housing manager.

Members learnt about incentives to encourage people in family housing to downsize if homes were too big for their needs and this would also be addressed via the new choice based letting scheme. Improvements to customer service had resulted from Council staff who had been trained to offer a walk-in advice service for Spirita customers, plus there was also a dedicated phone line at the Civic Centre to report repairs and a tenant-led panel scrutinised complaints.

The Group considered whether the partnership represented good value for money, debating the indicators such as whether a scheme received Homes and Communities Agency grant funding, how many homes had been built, funding arrangement and many more issues. The Group felt that the partnership continued to provide very good value for money in terms of providing affordable housing, albeit that this did not preclude the Council from working with other agencies in the future and considering other options.

### Annual review of leisure centre contract with Parkwood Leisure

The Council's partnership with Parkwood Leisure was the subject of scrutiny at November's meeting when it reviewed the past year's operation. The Group concluded that the partnership was working well. This third review provided some highlights and a few areas for improvement including:



- A high level of governance was in place and contract compliance was being achieved.
- Increase in visitor and Expression member numbers, refurbishment of gyms, successful Investors in People accreditation, introduction of free swimming for the over 60s (funding from the Government has since been withdrawn) and free swimming lessons were all successes.
- Implementing the Aiming High project to bring leisure to people with disabilities widened access to leisure.
- The apprenticeship scheme is working well. An advanced scheme will be developed and a graduate training scheme will be introduced.
- Customers have complained at some sites about poor standards of cleanliness and this could be addressed by recruiting extra staff where necessary
- An online booking system will be developed.
- Parkwood demonstrated its commitment to improving energy efficiency/reducing its carbon footprint eg via obtaining ISO 14001, raising staff awareness etc
- The GP referral scheme was working well
- Budget gyms opening up in Nottingham would pose a real competitive threat
- Joint use sites presented several issues in terms of litter, vandalism and cleanliness, but there were good relationships with schools
- The phone system at Rushcliffe will be replaced
- Family night at Rushcliffe is being re-pacakaged to attract more attendance. Junior pump session for teenagers was working well and the triathlon was proving popular, as was teenage gym sessions.

### Annual review of First Lets and future options

The Group scrutinised the First Lets web-based service which is run with Broxtowe and Gedling Borough Councils and helps marry good tenants with good landlords, create a buoyant rented sector and help prevent homelessness.

There had only been 39 tenancy lets in Rushcliffe and performance was not as high as expected. The Council was committed to the scheme until March 2011, but as the other two



partners wanted to merge First Lets with the Choice Based Lettings scheme, Members recommended that this course of action should be followed after thorough questioning, but yet still consider retaining the Good Tenants Scheme.

### Review of the South Nottinghamshire Community Safety Partnership

At January's meeting, the Group learnt about changes to the Partnership which was now aligned with the police division and could share resources and expertise over the three boroughs.

Members were pleased to learn that crime in Rushcliffe had dropped by over 10% (April to December 2010 compared with previous year), however anti-social behaviour had increased. Yet Rushcliffe still had the lowest crime figures of the three boroughs.

One of the highlights was the success of the Integrated Offender Management project which helped prevent re-offending by giving help with employment, drugs and family issues. The community safety officers had been pivotal in the success of this project where 70% of criminals involved had not re-offended. The police outlined how the Nottinghamshire Police was to be organised in future and reiterated that the partnership would still concentrate on a geographical basis and would target specific community problems. Another highlight for the coming year would be the development of the Rushcliffe Community Contact Centre which would be a good one-stop-shop for both organisations.

One area of concern given current budgetary pressures was working with young children to deter them from a life of crime, but there would probably not be enough funding for future diversionary tactics. The Group were informed that the South Nottinghamshire Community Safety Partnership was highly regarded and used as an example nationally.

### Update on the partnership with Nottinghamshire County Cricket Club

The Group were updated on the community benefits package and the Cotgrave Positive Futures project. Highlights over the past year included:

- Supporting the 34 club mark accredited clubs in the Borough
- Working with six schools in the Borough to provide coaching and links to clubs
- Encouraging children by making them match day mascots, donating tickets and bats to raise money for groups, schools and charities
- Ensuring that young people were included in the Academy and Emerging Players programmes
- Focussing on women and girls' cricket
- Progress with Positive Futures included a jewellery-making activity which had evolved into a social enterprise, there had been improved behaviour at school, a dance group set up and a huge reduction in anti-social behaviour.

Priorities for this coming year included more opportunities for young people aged 16 to 19 and expanding the apprenticeship scheme. The Group concluded that this partnership represented excellent value for money.
