Thorntons Holt

**RECEIVED FROM:** Applicant

### **SUMMARY OF MAIN POINTS:**

The applicant has submitted information to illustrate the difference in levels between the Thornton's Holt Camping Park and the site, particularly with reference to the position of the railway embankment between the two sites.

Reference is drawn to eyelines taken both from the Camping Park entrance and from within the site, and the applicant considers that this demonstrates that both the crematorium building and the wider site itself will simply not be visible.

Photos have also been provided in an attempt to show, on the approach to the Camping Park, how the former railway embankment screens the site from view, whilst other photos suggest that Thorntons Holt Camping Park will not be visible from within the Crematorium site either, due to the extent to which the site is naturally screened and it is suggested that this will be further improved through the woodland planting across the site.

### **PLANNING OFFICERS COMMENTS:**

The consideration of the relationship between Thorntons Holt and the application site has been discussed within the report and no additional comments made.

2. **NATURE OF REPRESENTATION:** Additional information regarding justification for non mains drainage on the site

**SUMMARY OF MAIN POINTS:**

Technical information and supporting information has been received to demonstrate why more sustainable forms of foul drainage are not possible on the site.

**PLANNING OFFICERS COMMENTS:**

Drainage matters in relation to surface water are considered at paragraph 183 of the report. In relation to foul drainage, in accordance with national planning policy and guidance, it is necessary for developments relying on anything other than a connection to a public sewage treatment plant to justify why this is the case. This has been provided and is considered acceptable. The Environment Agency has raised no objections to this form of provision in their consultation response. Technical matters will be considered by Building Regulations.
