### SUMMARY OF MAIN POINTS:

a. Concerns raised with regards to the operation of noisy machinery and reversing alarms on vehicles and impact on neighbouring amenity – the hours of use of operating noisy wood working machinery should be conditioned to be 08.00 - 15.00.

b. Comments also raised with regards to the tree/hedgerow planting originally proposed along the access driveway approved under 11/00888/FUL not having been carried out.

c. The length of time in determining the application has deterred objectors complaining to Environmental Health about noise hence nothing has been recorded in later years.

### PLANNING OFFICERS COMMENTS:

a. Environmental Health Officers have been consulted on hours of operation of the business including processing of the wood and the hours stated in the recommended conditions 2-6 are in line with their advice.

b. the proposed submitted site plan (drg. No. Blades/2021-2) shows the planting up of missing hedgerow along the access drive including

adjacent to the stables which has been secured by recommended Condition 8.

c. the delay in determining the application is as a result of ensuring that the submitted plans show all of the structures and buildings on the site. Environmental Health would investigate any noise complaints under statutory noise nuisance if the matter was brought to their attention. Concerns raised regarding noise raised as a result of consultation on the planning application have been addressed within the Committee Report.
