Record of Decisions taken by Cabinet – Tuesday, 11 January 2022

At a meeting of the Cabinet held on Tuesday, 11 January 2022 the following decisions were reached on the items listed in the attached schedule.

The implementation of any key decisions are suspended until the call-in period has expired without a call-in being validly invoked.

Under the Rushcliffe Borough Council Constitution, call-in is available in respect to key decisions only.

The call-in deadline for any key decisions contained in this Decision Notice is before the end of the working day on Thursday, 20 January 2022. Subject to any call-in request being received, all the decisions will be actioned after Thursday, 20 January 2022.

Any Member of the Council shall be entitled to call for a decision to be suspended. To effect the call-in procedure, the appropriate form should be completed and returned to the Chief Executive by the end of the working day on Thursday, 20 January 2022 .

PROCUREMENT STRATEGY UPDATE

It was RESOLVED that:

- a) the Procurement Strategy 2022 to 2025/26 (Appendix A) be adopted; and
- b) any changes to the Strategy until 2025/26 be delegated to the Director – Finance and Corporate Service, in consultation with both the Council’s Monitoring Officer and Portfolio Holder for Finance and Customer Access.

REASON FOR DECISIONS

Approval of the Procurement Strategy will deliver a more proactive approach to procurement, a clear focus on social and environmental values, and procurement with local businesses. The Procurement Strategy also demonstrates the Council’s commitment to continue to deliver value for money and ensure it retains its commercial focus.

HICKLING PARISH NEIGHBOURHOOD PLAN

It was RESOLVED that:

- a) the decision not to accept the Examiner's recommended modifications 09 and 10 to the Hickling Parish Neighbourhood Plan be confirmed;
- b) the Hickling Parish Neighbourhood Plan Revised Decision Statement and its publication be approved;
- c) the holding of a referendum for the Hickling Parish Neighbourhood Plan, with the area for the referendum being the Parish of Hickling be approved; and
- d) the Director – Development and Economic Growth be granted delegated authority to make any necessary final minor textual, graphical and presentational changes required to the referendum version of the Hickling Parish Neighbourhood Plan.

REASON FOR DECISIONS

The submitted Hickling Parish Neighbourhood Plan has been assessed by an independent Examiner who concluded that, subject to a number of recommended modifications, the Plan should proceed to referendum. The Cabinet in October 2021 considered each of the recommended modifications and decided to accept them all with the exception of modification 09, which relates to Policy H11 (The Wharf), and modification 10, which would be a consequential amendment to Policy 10 (Housing Provision).

In accordance with relevant statutory requirements, the Borough Council has consulted on the proposed decision not to accept those two modifications, and in total, five representations have been received. Following consideration of those consultation responses, it has been decided that the Plan should be put to referendum in the Parish of Hickling to determine if local people support it.
