### **NON-KEY DECISIONS**

#### **REVENUE AND CAPITAL BUDGET MONITORING 2021/22 - QUARTER 3**

**It is RESOLVED that Cabinet approves the attached report both noting and agreeing to:**

- a) the expected revenue budget efficiency for the year of £0.054m inclusive of committed reserves;
- b) the planned use of reserves totalling £4.140m (detailed in Appendix A of the report);
- c) the capital underspend of £5.1m; and
- d) the expected outturn position for Special Expenses of £15.7k deficit.

## **HOUSING DELIVERY PLAN 2022-2027**

**It was RESOLVED that** Cabinet approves the Housing Delivery Plan 2022 – 2027 (Appendix 1 of the report) and Action Plan (Appendix 2 of the report).

### **REASON FOR DECISIONS**

The Plan supports the Council's statutory duties and the Council's Corporate Priorities. It also supports and links with corporate and partnership plans such as the South Nottinghamshire Homelessness Strategy, the Carbon Management Plan, and the Empty Homes Strategy.

The Plan provides a direction, focus and the performance framework for the delivery of housing and related services.

### **PSPO - DOG CONTROL**

**It was RESOLVED that** the proposed Public Space Protection Order for the control of dog related anti-social behaviour as set out in Appendix 1 of the report be endorsed and recommended for approval by Full Council.

### **REASON FOR DECISIONS**

The Council has completed extensive consultation, which overwhelmingly supports the adoption of a Public Spaces Protection Order for the control of dogs within the Borough.
