Record of Decisions taken by Cabinet - Tuesday, 11 February 2020

At a meeting of the Cabinet held on Tuesday, 11 February 2020 the following decisions were reached on the items listed in the attached schedule.

The implementation of any key decisions are suspended until the call-in period has expired without a call-in being validly invoked.

Under the Rushcliffe Borough Council Constitution, call in is available in respect to key decisions only.

The Call-in deadline for any key decisions contained in this Decision Notice is before the end of the working day on Thursday, 20 February 2020. Subject to any Call in request being received, all the decisions will be actioned after Thursday, 20 February 2020.

Any Member of the Council shall be entitled to call for a decision to be suspended. To effect the Call-in procedure, the appropriate form should be completed and returned to the Chief Executive by the end of the working day on Thursday, 20 February 2020.

BUDGET AND FINANCIAL STRATEGY 2020/21

It was RESOLVED that Cabinet recommends that Council

- a) adopts the budget setting report and associated financial strategies 2020/21 to 2024/25, as set out in the Annex to the report, including the Transformation Strategy and Efficiency Plan, as set out in Appendix 3 of the Annex, to deliver efficiencies over the five-year period;
- b) adopts the Capital Programme as set out in Appendix 4 of the Annex;
- c) adopts the Capital and Investment Strategy as set out in Appendix 5 of the Annex;
- d) sets Rushcliffe's 2020/21 Council Tax for a Band D property at £142.74; and
- e) sets the Special Expenses for West Bridgford, Ruddington and Keyworth, as set out in Appendix 1 of the Annex, resulting in the following Band D Council Tax levels for the Special expenses Areas:

- i) West Bridgford £48.51
- ii) Keyworth £3.76
- iii) Ruddington £4.12

REASON FOR DECISIONS

To comply with the Local Government Finance Act (1972) and ensuring the budget enables corporate objectives to be achieved.

The Council is required to set a balanced budget and that it has adequate funds and reserves to address its risks.

EAST MIDLANDS DEVELOPMENT CORPORATION It was RESOLVED that

- a) the statement of intent prepared and approved by the Development Corporation Oversight Board be endorsed;
- b) Rushcliffe Borough Council's involvement in the establishment of the Development Corporation and the required interim arrangements be supported;
- c) the potential budget impact of the interim arrangements be noted;
- d) a Member Working Group be set up and be regularly consulted on the progress of the development corporation work over the next two years, during the period of the interim delivery vehicle; and
- e) the report be referred to Council on 5 March 2020 for endorsement.

REASON FOR DECISIONS

The establishment of the Development Corporation would attract national and international investment and development into the East Midlands, and more specifically into the Ratcliffe on Soar Power Station site.

The decommissioning of the Ratcliffe on Soar Power Station in 2025 would have a significant impact on the Borough financially and the potential to leave a very large derelict site at the entrance to the Borough. The Development Corporation would provide greater opportunity for the redevelopment of the site.

COLSTON BASSETT NEIGHBOURHOOD PLAN It was RESOLVED that

- a) all of the Examiner's recommended modifications to the Colston Bassett Neighbourhood Plan be accepted;
- b) the Colston Bassett Neighbourhood Plan Decision Statement and its publication be approved;
- the holding of a referendum for the Colston Bassett Neighbourhood Plan, with the area for the referendum being the Parish of Colston Bassett be approved; and
- d) the Executive Manager Communities be granted delegated authority to make any necessary final minor external graphical and presentational changes required to the referendum version of the Colston Bassett Neighbourhood Plan.

REASON FOR DECISIONS

The Borough Council, as Local Planning Authority, has a statutory duty to assist in the production of Neighbourhood Plans where communities wish to produce them under the Localism Act 2011.

The Plan is now in a position to be put to referendum in Colston Bassett Parish in accordance with the requirements of the Localism Act 2011.
